1. Course Outline

Supranational decisions increasingly permeate national politics but are often taken in rather closed settings which involve executive or technocratic actors only. Yet, as the examples of the failed 2005 referenda on a European Constitution or debates on European policies amid the debt crisis show, this mode of decision-making is increasingly challenged in public. Supranational decisions figure prominently in the news, public opinion is much more aware but also more diversified, and various societal actors ranging from social movements to political parties actively mobilize on European and international questions.

Based on the emerging research agenda, the course provides a systematic overview of this politicization of supranational governance. Based on recent empirical literature, the participants delve into the different arenas in which politicization takes place, carve out the emerging lines of political conflict on European integration, and finally discuss the resulting challenges for decision-making in the EU and other international institutions. On this basis, the course aims to enable participants to assess and to apply the politicization concept to various questions of European and international politics.

We address students who already control some knowledge on European multilevel governance, who are willing to engage in both the substantial and methodological issues of the literature discussed, and who are prepared to actively participate during the individual sessions. Assignments include one presentation of a scholarly article and a term paper which applies one of the discussed aspects to a freely chosen empirical issue of supranational governance.

Session aims to make students aware of the 'permissive consensus' assumption and its declining validity over time. As a sideline, session should signal how strongly the focus on societal politicization challenges the often detached nature of executive decision-making in Europe.

Politicization of supranational governance: Structuring political conflict on European Integration

Drawing on the findings in earlier sessions, we discuss approaches that try to uncover the structure of political conflict on European integration and the underlying cleavages. While there remains disagreement in the scholarly literature on the exact shape of the political space, both, traditional conflict dimensions along class and utilitarian assessments but also newly emerging cleavages on the basis of political values structure the contents of politicization.

Politicization of international governance beyond the EU

The basic aim is to outline a causal link between the authority of supranational governance and the extent of societal politicization. Based on this link, both variation of EU politicization over time and differences to less authoritative international institutions can be explained.
